NOTES FROM THE LAST BOARD MEETING #1074

An Action meeting of the Board of School Directors of the North Penn School District was held at the Educational Service Center on Thursday, November 16, 2017.

The meeting was called to order by Vincent Sherpinsky, Board President, at 7:30 p.m. Vincent Sherpinsky reminded those in attendance that the meeting was being videotaped by the school district for the community cable channel.
