SCHOOL BOARD REPORT

NOTES FROM THE LAST BOARD MEETING #996

The monthly meeting of the Board of School Directors of the North Penn School District was held at the Educational Service Center on Thursday, June 21, 2012.

The meeting was called to order by Vincent Sherpinsky, board president, at 7:30p.m. Vincent Sherpinsky reminded those in attendance that the meeting was being videotaped by the school district for the community cable channel. Vincent Sherpinsky requested that members of the audience wishing to address the board should come to the microphone, state their name and address, sign the audience of citizens log book, and limit their questions and comments to permit time for all those who wished to speak to the board.

During the Audience of Citizens the following persons spoke: Bill Patchell of Lansdale had general comments and Mr. Yoder of Hatfield had comments regarding the budget.

The board approved the following items:

- Expulsion for student #062112-1 whose name is on file in the Office of the Superintendent;
- Settlement Agreements for student # 062112-2 and #062112-3 whose names are on file in the Office of the Superintendent.
- Medical director, medical examiners, and dental examiners listed for the 2012-2013 school year;
- The rate of 14.11/hour for medical and dental clerks for the 2012-2013 school year;
- Adoption of Science and Social Studies textbooks;
- Adoption of Mathematics textbooks;
- Submitting PlanCon Part H documents to the Pennsylvania Department of Education for the Inglewood Elementary School Additions and Renovations
- Approving the letter to PennDOT regarding A.M. Kulp Elementary School;
- Waiving the 2012-2013 real estate taxes on the parcel 46-00-03589-00-1, for Montgomery Township; Federal and Pennsylvania state grants as listed;
- Submitting PlanCon Part H documents to the Pennsylvania Department of Education for the NPHS Natatorium Phase 1 & 2 Alterations and Additions;
- Changing Special Olympics Advisor Group from 3 to 2 and establishing a Special Olympics Track and Field Meet Director position at a Group 1 for the years in which NPSD hosts the Special Olympics event;
- Resolution to participate in the Southeastern Pennsylvania Schools Trust for Medical Benefits;
- Authorizing Bonnett Associates, Inc., to begin the process of subscribing to Green Globe and submitting to the online evaluation for the purpose of determining Qualification for a Green Globes rating at a cost of \$500.00;
- General insurance package for the 2012-2013 fiscal year to Specht Insurance Group in the amount of \$417,642;
- Dischell, Bartle and Dooley as Solicitors effective July 1, 2012 through June 30, 2013, at the rate of \$135 for general legal and \$150 for special education;

- Susan Krause as Assistant Secretary to the Board of School Directors for a one year term effective July 1, 2012 through June 30, 2013, and the establishment of a Bond in the amount of \$5000 with the premium to be paid by the school district.
- Donna Mengel as a nonmember Treasurer of the Board of School Directors for a one year term effective July 1, 2012 through June 30, 2013, and the establishment of a Bond in the amount of \$5000 with the premium to be paid by the school district. Compensation for duties assigned by the Director of Business Administration shall not exceed \$100 per month;
- Contract with TransPar to provide transportation management services;
- 3-year lease/purchase agreement, with TD Bank, at an interest rate of 1.17% and an annual cost of \$280,734.09 (for a contract cost of \$842,202.27 (includes interest);
- Continuing to commit funds for Retirement Rate Stabilization in the amount of \$5,873,236, continue the Self-Funded Healthcare Reserve Fund in the amount of \$2,500,000, and assign reserve fund for future contributions to the Self-Funded Healthcare Reserve, in an amount to be determined;
